Consent to Undertake Sewerage Customer Contact and Billing Services

1. Introduction

- 1.1 AADC, by way of letter dated 5 July 2011, has applied to the Bureau for its Consent pursuant to Condition 2, paragraph 2 of the Licence to undertake Sewerage Customer Contact and Billing Services for the Abu Dhabi Sewerage Services Company (ADSSC), in the Al Ain region of Abu Dhabi.

2. Definitions

- 2.1 Terms used in this Consent shall, unless defined herein or the context otherwise admits, have the same meanings as ascribed to them in Law No (2) or the Licence.

AADC means Al Ain Distribution Company.

ADSSC means Abu Dhabi Sewerage Services Company.

Bureau means the Regulation and Supervision Bureau for the Water, Wastewater and Electricity Sector in the Emirate of Abu Dhabi as established under Law No (2).

Consent means this consent granted by the Bureau to AADC to undertake Sewerage Customer Contact and Billing Services.

Law No (2) means Law No (2) of 1998 Concerning the Regulation of the Water and Electricity Sector in the Emirate of Abu Dhabi, as amended.

Licence means the distribution and supply licence number ED/L01/007 granted by the Bureau to AADC, as modified from time to time.

Licensed Activities means those activities which AADC is authorised to carry out under its Licence.

Person means any person, company, body corporate, establishment, partnership or other entity having an independent legal personality.

Sewerage Customer means any Person who:

- (a) has an agreement with ADSSC for Sewerage Services; and
- (b) is the Person in whose name an account is held with at ADSSC.

Sewerage Customer Contact and Billing Services means the following services to be given by AADC to ADSSC through utilising AADC's customer contact and billing services infrastructure:

- (a) Sewerage Customer register;
- (b) Sewerage Customer care services;
- (c) tariff and billing services for Sewerage Customers; and
- (d) tasks associated with the above.

Sewerage Services means the combined activities of sewerage, wastewater treatment and disposal.

3. Consent

- 3.1 The Bureau, having duly considered the application from AADC, grants its Consent to AADC under Condition 2, paragraph 2 of the Licence, to AADC undertaking Sewerage Customer Contact and Billing Services for ADSSC, in the Al Ain region of Abu Dhabi.

4. Conditions to this Consent

4.1 This Consent is subject to the following conditions:

- (a) AADC will continue to comply with all the requirements of Law No (2) and the Licence in respect of its Licensed Activities.
- (b) This Consent must not adversely affect the operations and costs of AADC's Licensed Activities. AADC shall ensure the financial ring fencing between the activities authorised under this Consent and its Licensed Activities and ensure that there is no cross-subsidy.
- (c) AADC will meet health, safety and environmental related requirements imposed by the Bureau or any other authority having jurisdiction over AADC's activities.
- (d) AADC will, in relation to the activities covered in this Consent, comply with all the requirements of Condition 9 of the Licence (Separate accounts for Separate Businesses) as if the activities covered by this Consent are a Separate Business, as defined in the Licence.
- (e) AADC shall not undertake the activities authorised under this Consent unless it has obtained and kept current any necessary consent, permit, licence or other form of authorisation required from authorities other than the Bureau having jurisdiction over such activities.
- (f) AADC shall comply with all other applicable legislation relating to the activities authorised under this Consent.

5. Duration of Consent

5.1 This Consent shall remain valid up to 31 December 2015.

5.2 Not less than 30 days prior to the expiry of this Consent as specified in paragraph 5.1, AADC must write to the Bureau to either:

- (a) request an extension of this Consent; or


